Foreword

The text of document 61/2166/FDIS, future fourth edition of IEC 60335-2-30, prepared by the IEC Technical Committee 61, was submitted to the IEC-CENELEC parallel vote.

As a result of the Kista meeting of CENELEC TC 61 in May 2002, a draft amendment prAA containing the relevant existing common modifications was submitted to the formal vote.

The texts of the FDIS and the prAA were approved by CENELEC as a new edition of EN 60335-2-30 on 2003-03-18.

This European Standard replaces EN 60335-2-30:1997 + A1:2000.

The following dates are applicable:

- latest date by which the EN has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2004-03-01
- date on which national standards conflicting with the EN have to be withdrawn (dow) 2006-03-01

This part 2 has to be used in conjunction with EN 60335-1, Household and similar electrical appliances – Safety – Part 1: General requirements. It was established on the basis of the 2002 edition of that standard. Amendments and revisions of Part 1 have also to be taken into account and the dates when such changes become applicable will be stated in the relevant amendment or revision of Part 1.

This part 2 supplements or modifies the corresponding clauses of EN 60335-1, so as to convert it into the European Standard: Safety requirements for electric room heaters.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text of Part 1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.;
- subclauses, notes and annexes that are additional to those in the IEC standard are prefixed with the letter Z.

NOTE 2 The following print types are used:

- requirements: in roman type;
- *test specifications*: in italic type;
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3. When a definition concerns an adjective, the adjective and the associated noun are also in bold.

Special national conditions causing a deviation from this European Standard are listed in annex ZA and are in addition to those in EN 60335-1.

National deviations from this European Standard are listed in Annex ZB and are in addition to those in EN 60335-1.

p NOTE In this document, p is used in the margin to indicate instructions for preparing the printed version.


Introduction

p Add:

An investigation by CENELEC TC 61 has shown that all risks from products within the scope of this standard are fully covered by the Low Voltage Directive, 73/23/EEC. For products having mechanical moving parts, a risk assessment in accordance with the Machinery Directive, 98/37/EC, has shown that the risks are mainly of electrical origin and consequently this directive is not applicable. However, the relevant essential safety requirements of the Machinery Directive are covered by this standard together with the principal objectives of the Low Voltage Directive.

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-30: Particular requirements for room heaters

1 Scope

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of electric room heaters for household and similar purposes, their **rated voltage** being not more than 250 V for single-phase appliances and 480 V for other appliances.

NOTE 101 Examples of appliances that are within the scope of this standard are

- convector heaters;
- **fan heaters**;
- heaters for use in greenhouses.
- liquid-filled radiators;
- panel heaters;
- radiant heaters;
- tubular heaters;

Appliances not intended for normal household use but which nevertheless may be a source of danger to the public, such as appliances intended to be used by laymen in the shops, in light industry and on farms, are within the scope of this standard.

As far as is practicable, this standard deals with the common hazards presented by appliances which are encountered by all persons in and around the home. However, in general, it does not take into account

- the use of appliances by young children or infirm persons without supervision;
- playing with the appliance by young children.

NOTE 102 Attention is drawn to the fact that

- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements may be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour and similar authorities;
- for appliances intended to be used in the presence of combustible dust, for example in barns or stables, additional requirements may be necessary.

NOTE 103 This standard does not apply to

- appliances intended exclusively for industrial purposes;
- appliances intended to be used where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas);
- heaters that are built into air conditioners (IEC 60335-2-40);
- clothes dryers and towel rails (IEC 60335-2-43);
- heaters for saunas (IEC 60335-2-53);
- thermal-storage room heaters (IEC 60335-2-61);
- heating appliances for breeding and rearing animals (IEC 60335-2-71);
- foot warmers and heating mats (IEC 60335-2-81);
- flexible sheet heating elements for room heating (IEC 60335-2-96);
- heated carpets;
- central heating systems;
- heating cables (IEC 60800).
