Foreword

The text of document 61E/422/FDIS, future first edition of IEC 60335-2-99, prepared by SC 61E of the IEC Technical Committee 61, Safety of household and similar electrical appliances, was submitted to the IEC-CENELEC parallel vote and was approved by CENELEC as EN 60335-2-99 on 2003-07-01.

The following dates are applicable:

- latest date by which the EN has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2004-04-01
- date on which national standards conflicting with the EN have to be withdrawn (dow) 2006-07-01

This part 2 has to be used in conjunction with EN 60335-1, Household and similar electrical appliances – Safety – Part 1: General requirements. It was established on the basis of the 2002 edition of that standard. Amendments and revisions of Part 1 have also to be taken into account and the dates when such changes become applicable will be stated in the relevant amendment or revision of Part 1.

This part 2 supplements or modifies the corresponding clauses of EN 60335-1, so as to convert it into the European Standard: Safety requirements for commercial electric hoods.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text of Part 1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.;
- subclauses, notes and annexes that are additional to those in the IEC standard are prefixed with the letter Z.

NOTE 2 The following print types are used:

- requirements: in roman type;
- *test specifications*: in italic type;
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3. When a definition concerns an adjective, the adjective and the associated noun are also in bold.

There are no special national conditions causing a deviation from this European Standard, other than those listed in Annex ZA to EN 60335-1.

There are no national deviations from this European Standard, other than those listed in Annex ZB to EN 60335-1.

p NOTE In this document, p is used in the margin to indicate instructions for preparing the printed version.

Introduction

p Add:

An investigation by CENELEC TC 61 has shown that all risks from products within the scope of this standard are fully covered by the Low Voltage Directive, 73/23/EEC. For products having mechanical moving parts, a risk assessment in accordance with the Machinery Directive, 98/37/EC, has shown that the risks are mainly of electrical origin and consequently this directive is not applicable. However, the relevant essential safety requirements of the Machinery Directive are covered by this standard together with the principal objectives of the Low Voltage Directive.

The text of the International Standard IEC 60335-2-99:2003 was approved by CENELEC as a European Standard without any modification.

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-99: Particular requirements for commercial electric hoods

1 Scope

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of electrically operated commercial **hoods** intended for installation above commercial cooking appliances such as ranges, griddles, griddle grills and deep fat fryers, and not intended for household use, their **rated voltage** being not more than 250 V for single phase **hoods** connected between one phase and neutral, and 480 V for other **hoods**. Only single complete units and **hoods** supplied as separate parts which when assembled form a complete working **hood**, incorporating a fan, are within the scope of the standard.

NOTE 101 **Hoods** are used, for example in restaurants, canteens, hospitals and commercial enterprises such as bakeries, butcheries, etc.

The **hood** may be used above one or more appliance of the same or different types.

So far as is practicable, this standard deals with the common hazards presented by these types of appliances.

NOTE 102 Attention is drawn to the fact that:

- for **hoods** intended to be used in vehicles or on board ships or aircraft, additional requirements may be necessary;
- in many countries additional requirements including ventilation requirements are specified by the national health authorities, the national authorities responsible for the protection of labour and similar authorities;

NOTE 103 This standard does not apply to:

- domestic range **hoods** (IEC 60335-2-31);
- purpose-built **hoods**, although this standard can be used as a guide (a purpose-built **hood** is either constructed on-site or specially constructed in the factory and is not mass produced);
- **hoods** not incorporating a fan;
- **hoods** designed exclusively for industrial purposes;
- **hoods** intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas).

NOTE 104 Requirements for **hoods** with externally mounted fans are under consideration.
